### **Course Description**

This course brings together students from the University of Salzburg in Austria and the New School to study together some of the most urgent problems confronting the world today. Guided by insights from political psychology, students investigate cases of mass violence and reconciliation. Political psychology promotes an interdisciplinary understanding of political processes and human relationships, drawing on the disciplines of political science and psychology as well as the methods of sociology, history, and economics. Students use this perspective to research the origins of violence, aggression, and altruism. The class also compares cultural perceptions of these phenomena in Austria and the United States. The language of instruction is English.
